NOTICE OF REGISTRATION OF TRADE NAME

On August 13, 1999, Chautauqua Airlines, Inc.¹ submitted an application under Part 215 of our rules to register the trade name "Republic Airways".

Part 215 of the Department's regulations provides that any carrier wishing to use an alternative trade name must first register that name with the Department. The rule further states that the Department may register a trade name after the carrier gives notification to similarly named carriers of the proposed use of the trade name. There are no similarly named carriers; hence, no notification was required.

Since Chautauqua has complied with the requirements of Part 215, we acknowledge the registration of the trade name "Republic Airways" by Chautauqua Airlines for use in its operations.
