NOTICE OF REGISTRATION OF TRADE NAME

On October 6, 1999, Sky Trek International Airlines, Inc.,¹ submitted an application under Part 215 of our rules to register the trade name "Discovery Airlines."

Part 215 of the Department's regulations provides that any carrier wishing to use an alternative trade name must first register that name with the Department. The rule further states that the Department may register a trade name after the carrier gives notification to similarly named carriers of the proposed use of the trade name. In this case, there are no similarly named carriers; hence, no notification was required.

Since Sky Trek has complied with the requirements of Part 215, we acknowledged the registration of the trade name "Discovery Airlines" orally on October 7, and we confirm that action here.
