FINAL ORDER

By Order 2000-4-20, served April 19, 2000, we directed all interested persons to show cause why we should not make final our tentative findings and conclusions that Trans Borinquen Air, Inc., did not meet the U.S. citizen requirements of the Statute, and denying it the section 41102 certificate authority it sought. Interested persons were given 14 days to file objections to the order.

No objections to the show-cause order were received.

ACCORDINGLY,

1. We find that Trans Borinquen Air, Inc., does not meet the U.S. citizen requirements of the Statute.
2. We deny the application of Trans Borinquen Air, Inc., in Docket OST-99-6173 for authority to conduct interstate charter all-cargo air transportation.¹

¹ By this order, we deny only the interstate authority requested by Trans Borinquen. Denial of a foreign certificate is subject to Presidential review under 49 U.S.C. 41307 and will be handled in a separate order.
