NOTICE OF REGISTRATION OF TRADE NAME

By Order 2001-9-19, served October 1, 2001, the Department issued Biz Jet Services, Inc. (Biz Jet) a certificate authorizing it to engage in interstate charter air transportation of persons, property and mail. By Order 2000-11-13, served December 3, 2001, we issued Biz Jet a companion certificate authorizing it to engage in foreign charter air transportation.¹ On December 11, Biz Jet requested that the Department register "Avolar" as a trade name to be used in connection with Biz Jet's proposed operations.

Part 215 of the Department's regulations provides that any carrier wishing to use an alternative trade name must first register that name with the Department. The rule further states that the Department may register such name after the carrier gives notification to similarly named carriers of the proposed use of the name. Since there are no other carriers with a similar name, the notice requirement of Part 215 has been met. Under these circumstances, we hereby register "Avolar" as a trade name to be used by Biz Jet in its certificated air carrier operations.
