**LINES, INC., AND AIR NEW ZEALAND LIMITED UNDER 49 U.S.C. SECTIONS 41308 AND 41309 FOR APPROVAL OF AND ANTITRUST IMMUNITY FOR ALLIANCE AGREEMENTS:**

The Department tentatively grants approval of and antitrust immunity for an Alliance Agreement between United Air Lines, Inc. ("United") and Air New Zealand Limited ("Air New Zealand" or ANZ"), under 49 U.S.C. Sections 41308 and 41309. If made final, the Department will direct the Joint Applicants to resubmit their Alliance Agreement for review no later than five years from the service date of the Final Order. If the Joint Applicants choose to operate under a common name or brand, they will have to obtain advance approval from the Department before implementing the arrangement.
