Order 2003-11-2, the Department establishes new intra-Alaska mainline mail rates effective four days after the service date of this order because of revised data submitted by Everts Air Cargo (EAC). Also, directs EAC, Lynden Air Cargo (LAC), and Era Aviation (ERA), to begin compiling past-period data so that in the next update we can examine whether it is appropriate to add their data in determining the long-term trends in unit costs, and, refers EAC to our Office of Enforcement for investigation.
