The Department approves this settlement and provisions of this order as being in the public interest and finds that: (1) Frontier Airlines has violated 14 CFR 399.84 by publishing deceptive advertisements that failed to comply with the Department's full-fare advertising requirements. (2) By engaging in the conduct and violations described, Frontier has also violated 49 U.S.C. 41712. Therefore, Frontier, and all other entities owned or controlled by or under common ownership with Frontier, and their successors and assignees, are ordered to cease and desist from violations of 49 U.S.C. 41712 and 14 CFR 399.84; and is assessed \$18,000 in compromise of civil penalties that might otherwise be assessed for the violations.
